Positioning Wheelchair Back Cushion, Planar Back with Lateral Supports, Width Less than 22 inches, Any Height, Including Any Type Mounting Hardware

Medicare Coverage Criteria

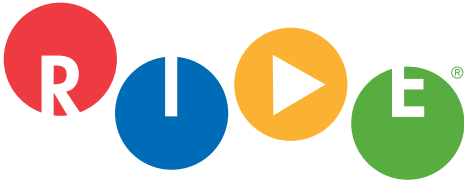
A positioning back cushion (E2620) is covered if the two criteria below are met:

1. The beneficiary has a manual wheelchair or a power wheelchair with a sling/solid seat/back and the beneficiary meets Medicare coverage criteria for it; AND
2. The beneficiary has any significant postural asymmetries that are due to one of the diagnoses listed in the ICD-10 Reference guide for the Ride Java Back.

The only products, which may be billed using code E2620, are those products for which the Pricing, Data Analysis, and Coding (PDAC) contractor has made a written coding verification. A Product Classification List with products which have received a coding verification can be found on the PDAC website (www.dmepdac.com).

Helpful Tips

- Be certain that the clinical information documents a significant postural asymmetry; the diagnosis alone does not qualify the client for the specialty back.
